The Las Vegas City Employees' Association is an independent labor association not affiliated with the AFL/CIO or any other national union. The Las Vegas City Employees' Association was established in 1950 as a 501 C (3) non-profit corporation to represent the Classified City of Las Vegas employees. In 1969 the Legislature passed NRS288, which allows for collective bargaining for public employees in Clark and Washoe Counties. The major purposes of the LVCEA are: negotiate and protect labor contracts and represent members in disciplinary actions and employment issues with the City of Las Vegas. The Las Vegas City Employees' Association operates solely from members dues.
